Bids in sealed envelope clearly marked “*Request for Proposals in connection with Consultancy Services for the Review of third Party Liability Insurance Covers submitted by Contractors for Construction Works in Mauritius*” and reference number: **MNI/ OIB 07 OF 2022-2023** should be addressed to **The Permanent Secretary, Ministry of National Infrastructure and Community Development (National Infrastructure Division)**, and deposited in the **Bid Box situated on the 10th Floor, Medine Mews Building, Chaussee Street, Port Louis** on or before **Monday 17th October 2022 up to 13 00 hours** (local time) at latest. Bids by post, courier or hand delivered should reach the same address by the same date and time. Late bids will be rejected.

Bids will be opened in the Conference Room of the **Ministry of National Infrastructure and Community Development (National Infrastructure Division), 10th Floor, Medine Mews Building, Chaussee Street, Port Louis** on the same day at **13 30 hours** in the presence of bidders /bidders’ representatives who choose to attend.
6. The **Ministry of National Infrastructure and Community Development (National Infrastructure Division)** reserves the right to:
 - (a) accept or reject any bid; and
 - (b) annul the bidding process and reject all bids at any time prior to contract award, without incurring any liability towards the bidder.
